For the ninth year, the Nebraska Coaches Association, with the financial support of Farm Bureau Mutual Insurance of Nebraska, will award eight \$500 scholarships. These awards are intended for those senior student athletes that are in the top 25% of their class, participated in two sports for at least two years, and lettered in two sports. The selection committee will be meeting the last week of April, so we will need all applications in our office by **April 1**. We ask your cooperation in providing the application form to deserving students or to your guidance counselor for distribution. (Please make sure your NSAA District number is filled in on the application.) Three, one page promotional forms are also provided for you to hang in your locker rooms and the guidance office.

Once selections have been made, we will contact the recipient and the guidance office of each scholarship winners' school so the award may be announced at graduation ceremonies. You are the vehicle for getting the information to your student-athletes and we appreciate your cooperation! A certificate symbolizing the award will be presented to the eight winners at the Nebraska Coaches Association Awards and Recognition Banquet on Thursday, August 3, in Lincoln. The recipients and their parents will be guests of the NCA. The actual award will be presented to the student after the successful completion of their first semester of college.
